Online Applications are invited from Indian Citizen in prescribed format from the intending candidates for selection of candidates for undergoing 12 months Fishery Demonstrator Training Course for the session 2019- 20.

### Eligibility of Candidates:

- 1) Essential Qualification: - H.S.S.L.C or equivalent (10+2 examination) passed from any recognized Board/ Council.
- 2) Age: - 18 years and not more than 30 years as on 01.01.2019.

3) Reservation:- The Reservation Rule of Govt. of Assam will apply against the seats.
