**EXPRESSION OF INTEREST (EoI)**

FISHFED, Assam is a State level Cooperative Federation of Primary Fishery Cooperatives of Assam. FISHFED has a number of infrastructures including Fishery project comprising of 303 bighas of land near Morigaon. This site is basically low-lying area and quite suitable for different fish-based activities, aqua-tourism and post harvest and market related activities including cold room infrastructure, modern fish retail outlets, development of modern intensive aquaculture projects, etc.

In order to utilize the above infrastructures, FISHFED invites proposal from interested reputed entrepreneurs/ State Government organizations/federations/ Cooperatives/Companies etc. having adequate experiences in the line for development of projects relating to development of modern intensive aquaculture projects, Aqua-tourism etc., post harvest activities including establishment of modern hygienic fish retail outlets and other innovative proposals relating to the above subject. The applicant will have to submit their proposals to the undersigned within 30 (thirty) days from the date of issue of publication of this advertisement along with detailed proposal and profile of the party. **This EoI will be the part of investment promotion in Assam under the advantage Assam initiative.**

**Eligibility criteria/Terms and conditions:**

- The applicants must be entrepreneurs / State Government organizations/federations/Cooperatives/Companies etc. having relevant experience of executing similar projects across the State/ Country.

- The applicants must have proven track record and sufficient experience in fish-based project activities as stated above. They have to submit documentary proof in this regard.
- Applicants must be financially and technically sound and must provide evidence of availability of sufficient financial resources/ credit linkage so that he/she can complete the project as per the plan and estimate to be submitted by the party under the direct supervision of Managing Director of FISHFED. The applicant has to submit last three years audited balance sheet (FY 15-16 to FY 17-18) with an average annual turnover in the last three financial years of Rs.5.0 Crores.
- The applicants have to submit one Preliminary Project Report (PPR) indicating tentative total cost including component wise cost details, tentative profit and income, etc. after physical verification of the sites at their own cost.
- The selected applicant will have to sign one Memorandum of Understanding (MOU) with the Managing Director of FISHFED, Assam in presence of the Senior Most Secretary of the Fishery Department, Govt. of Assam or his authorized representative.
- The selected applicant will have to complete the work under the guidance & supervision of Managing Director of FISHFED, Assam or his authorized representatives as per the agreement.
- The applicants must submit all details (as per Annexure 1) of experience pertaining to his/her involvement in development of modern intensive aquaculture projects covering all aspects of project management such as production enhancement, post-harvest operation and management.
- The Managing Director, FISHFED will shortlist the eligible entrepreneurs / State Government organizations/ federations/ Cooperatives/Companies etc. based on their experience and track record and will submit the list of short listed parties to the Fishery Department for necessary approval from the Government.
- The aforesaid project sites will be leased out to the highest valid bidder for a period of thirty years initially. The first ten years' tenure of lease value to be given by the successful bidders is Rs.76.420 lakh. Year wise details of lease value to be given by the successful bidder shall be collected from the Managing Director, FISHFED and the same will be the part of lease agreement.
- The selected applicant will have to submit one Detailed Project Report (DPR) within forty-five days from the date of intimation of the FISHFED that his/her

PPR has been accepted by the FISHFED and he is the valid highest bidder in terms of giving lease value to the FISHFED.

- The selected bidder will have to complete work in all respects as per plan & estimate and technical specifications etc. mentioned in the DPR.

**N.B: The applicants who have already entered into an Agreement pertaining to fishery related activities with the Government of Assam during Advantage Assam will be given preference.**
