The last date of submission of quotation at the office of the undersigned is 23<sup>rd</sup> Aug, 2022 up to 12.00 noon. p.m. The quotation will be opened on the same day at 12.30 pm where the bidders or their authorized representative may be present.

  - (i) 1 copy of Passport photo of the bidder
  - (ii) copy of PAN card
  - (iii) copy of GST Registration
3. The Condemnation Board will reserve the right to accept any or to reject all quotations without assigning any reason thereof and also not bind himself to accept the highest bidder.
4. The scrap materials will be available for inspection during office hours from 3<sup>rd</sup> Aug, 2022 to 23<sup>rd</sup> Aug, 2022 at the office of the Director of Fisheries, Assam, Guwahati.
5. The scrap materials will be sold on "as is where basis is". The auction process will be conducted in presence of the Condemnation Board.
6. The successful bidder has to deposit the bid amount by in the form of Bank Draft/Bankers Cheque in favour of "The Director of Fisheries, Assam, Guwahati" payable at Guwahati only to the undersigned before issuance of formal order to lift the scrap materials. The bid amount is excluding GST, hence the GST is to be paid by the recipient of the scraps as per the rates applicable at the time of submission of the bid amount.
7. The scrap materials will be disposed off on "as is where basis" and no guarantee for its worthiness or quality will be given by this department.
8. The auctioned scrap materials will be removed by the successful bidder within 7(seven) working days of depositing the bid amount, at their own expenses making good to any damage made to the office & campus if any.
