# Expression of Interest (EoI) for supply of Fish Feed

The Mission Director, Fishery Mission Society for Chief Minister Samagra Gramya Unnayan Yojana (FMS-CMSGUY) invites expression of Interest (EOI) from eligible firms for empanelment of firms for supply of 'Fish Feed' in the newly constructed 'Framers Individual Ponds' and 'Village Community Tanks' under NABARD's RIDF-XXIII Scheme covering 1811.33 ha area for the year 2018-19 under the scheme "Ghare Ghare Pukhuri Ghare GhareMaach"- a Flagship Programme of Department of Fisheries, Government of Assam.

Supply of fish feed under Chief Minister Samagra Gramya Unnayan Yojana (CMSGUY) is a convergence scheme with NABARD's RIDF-XXIII scheme as stated above. The EoI will be received up to Up to 12.00 noon of 4<sup>th</sup> March, 2019 (during office hours) and will be opened on the same day in presence of the authorized representative(s) of the firms as detailed below in para (III): <u>List of Important Dates and Time</u>.

The Eol must be delivered directly in the specified box in the office of the undersigned or may be posted to the undersigned so that it reaches by the last date and time specified above. The undersigned will not take any responsibility for late receipt of the Eol beyond the last date and time due to postal delay or any other reason.

Under this progamme, fish farmers who have completed their pond construction activities as per the Government norms under RIDF-XXIII, will be assisted through supply of 'Fish Feed' for two consecutive years, i.e. 2019-20 & 2020-21.

Detailed specifications and norms of the items to be supplied are as follows:

# (I) Specific Eligibility criteria/Terms & conditions for supply of 'Fish Feed':

- (i) All the information must be submitted in English and to be duly signed by the applicants.
- (ii) The feed should conform to ISI/ISO certification.
- (iii) The supplier should be a Registered Fish Feed Manufacturer/Authorized Dealer/ /Registered Fish Feed Supplier of Formulated Fish Feed. Proof of documents to be furnished along with Eol.
- (iv) FMS-CMSGUY as and when required may check and verify the proximate composition of feed stock randomly through any ICAR institute/Agriculture Universities (Central or State)/other such reputed research organization whether feed proximate composition is as per the prescribed composition stated at sub para (iii) of para (I) above or not. If such feed stock is not as per the prescribed proximate composition, FMS-CMSGUY may cancel or reject the entire feed stocks already delivered to the beneficiary/beneficiaries and no claims will be entertained in such cases, the supplier should replace the supplied feed stock and/or the FMS-CMSGUY will have the power to cancel the name from the list of empanelled suppliers.
- (viii). The supplier must have experience in scientific packaging and supply of fish feed to longer distance inside and outside the district/State including neighbouring States. Certificate issued by appropriate authority in this regard is to be furnished as part of proof of such experience.

(v) Government approved fish feed mill approved under any government scheme may also participate in EoI process if sufficient fish feeds are available in its own feed mill and can supply the fish feed to the farmers as per above specification of feed.

# (II). Where and how EoI to be submitted:

- (i) Eol to be submitted in the Office of the Mission Director, Fishery Mission Society-CMSGUY, Directorate of Fisheries, Assam, Meen Bhawan, Guwahati-16.
- (ii) The rate to be quoted by the supplier should be clearly indicated as per the following table.

- (iii) Quoting of rates above or below on percentage (%) basis will be rejected.
- (iv) The empanelled feed supplier is to ensure that such feed will be readily available in the district and sub divisional head quarter so that farmer can easily procure. Further on request of beneficiary, the supplier may supply the feed in convenient places of the farmers as per discussion. If require, helps from DFDO may be taken.
- (v) The sealed envelope super-scribed with "EoI for supply of Fish Feeds under CMSGUY programme" is to be clearly mentioned.
- (vi) FMS-CMSGUY will finalize the list of empanelled suppliers based on above criteria mentioned under sub para (i)-(vii) under para (I) and will recommend the **District Reference Rate (DRR-** the rate at which farmers can procure their fish feeds in any one of the empanelled suppliers).
- (vii) FMS-CMSGUY is not bound to accept the lowest rate quoted by a bidder as the District Reference Rate (DRR), as quality of feed is the prime importance under the project.
- (viii) After listing of empanelled supplier beneficiaries will be free to procure the fish seeds from the empanelled fish feed supplier at the **District Reference Rate (DRR)**.
- (ix) The empanelled fish feed supplier must be agreed to supply the fish feed as per the approved reference rate for which they will enter into an agreement with the concerned DFDO.
- (x) The DRR shall remain valid up to March, 31, 2021 or till the consignment is delivered and/or completed. In this regard, no claim will be entertained.

- The applicant must have sufficient stock of desired fish feed as per specification and a certificate from concerned DFDO in this regard will have to be furnished along with Annexure-1.
- The proposed supply volume may be increased or decreased as requirement and no payment will be considered against incomplete supply and found not satisfactory by this office.
- 5. The undersigned reserves the right to accept or to reject any or all the EoIs without assigning any reasons whatsoever and he does not bind himself to accept the lowest rate.
- 6. No material will be supplied for any of the above works by this office. All taxes, Royalty, Cess, transportation etc. required in connection with the supply to be borne by the selected firm.
- 7. The Fishery Mission Society will shortlist the eligible firm(s) and the decision of the Mission Director will be final based on the approval of the competent authority.
- 8. Once, the reference rate is finalised and approved, then the beneficiary will be free to choose/select the firm from the shortlisted firms.
- 9. The empanelled listed firms will be circulated to the concerned DFDOs for circulation to the beneficiaries. The DFDOs shall take necessary action for facilitating the procurement of the commodities directly by the beneficiaries from the empanelled list of firms.
