Expression of Interest (EoI) for supply of Fish Seed

The Mission Director, Fishery Mission Society for Chief Minister Samagra Gramya Unnayan Yojana (FMS-CMSGUY) invites expression of Interest (EOI) from eligible firms for empanelment of firms for supply of 'Fish Seed' in the newly constructed 'Framers Individual Ponds' and 'Village Community Tanks' under NABARD's RIDF-XXIII Scheme covering 1811.33 ha area for the year 2018-19 under the "Ghare Ghare Pukhuri Ghare Ghare Maach- a Flagship Programme of Department of Fisheries, Government of Assam".

Supply of fish seed under Chief Minister Samagra Gramya Unnayan Yojana (CMSGUY) is a convergence scheme with NABARD's RIDF-XXIII scheme as stated above. The EoI will be received up to Up to12.00 noon of 4th March, 2019 (during office hours) and will be opened on the same day in presence of the authorized representative(s) of the firms as detailed below in para (III): List of Important Dates and Time.

The Eol mustbe delivered directly in the specified box in the office of the concerned District Fisheries Development Officer (DFDO) or may be posted to the concerned DFDO so that it reaches by the last date and time specified above. The concerned DFDO will not take any responsibility for late receipt of the Eols beyond the last date and time due to postal delay or any other reason.

Under this progamme, fish farmers who have completed their pond construction activities as per the Government norms under RIDF-XXIII, will be assisted through supply of 'Fish Seed' for two consecutive years, i.e. 2019-20 & 2020-21.

Detailed specifications and norms of the items to be supplied are as follows:

(I) Specific Eligibility criteria/Terms & conditions for supply of 'Fish Seed':

- i. Size of the fish seed in the form of fingerling should be 4"-5".
- ii. <u>Indian Major Carp</u> i.e. Rohu, Catla and Mrigal and <u>Exotic Carp</u> i.e. Silver carp, Grass Carp and Common Carp are to be supplied as per the standard specification of ratio as per the Package of Practices (PoPs) on "*Fisheries and Aquaculture in Assam,2018*" of Assam Agricultural University.
- iii. As per the recommendations of the PoPs, the supplier should agree to supply the fish seed @ 8000 nos per hectare as per the size mentioned at para (i) above with six species combination of <u>Silver Carp</u>-15% (1200 nos), <u>Catla</u>-25% (2000 nos), <u>Rohu</u>-25% (2000 nos), <u>Grass Carp</u>-10% (800 nos), <u>Mrigal</u>-15% (1200 nos), <u>Common Carp</u>-10% (800 nos)
- iv. The supplier must have up to date Registration Certificate (i.e. current/renewed) from DFDO as Fish Seed producer, grower, seed raiser, seed supplier.
- v. The supplier must have own fish seed hatchery registered under the concerned office of the District Fisheries Development Officer. Such registered hatchery owners should have sufficient seed rearing infrastructure.
- vi. The supplier should have experience in supply of fish seed to longer distance inside and outside the district/State including neighbouring States. Certificate issued by DFDO in this regard is to be furnished.
- vii. Government fish farms may also participate in submission of EoI if sufficient fish seeds rearing area available in its own farm and can supply the fish seed to the farmers as per above specification.

(II). Where and how EoI to be submitted:

- (i) EoI to be submitted in the Office of the District Fisheries Development Officer of concerned District addressing 'District Fisheries Development Officer (DFDO)'............. [With detailed office address of the concerned DFDO].
- (ii) The rate to be quoted by the supplier should be clearly indicated as per the following table.

- (iii) The sealed envelope should be super-scribed with "Eol for supply of Fish Seeds under CMSGUY programme for ------district".
- (iv) District Level Selection Committee (DLSC) constituted under "Ghare Ghare Pukhuri, Ghare Ghare Maach" will finalize the list of empanelled suppliers based on above criteria mentioned under sub para (i)-(vii) under para (I) and will recommend the District Reference Rate (DRR- the rate at which farmers can procure their fish seeds from one of the empanelled suppliers).
- (v) DLSC is not bound to accept the lowest rate quoted by a bidder as the District Reference Rate (DRR), as quality of seed is the prime importance under the project.
- (vi) After listing of empanelled suppliers, beneficiaries will be free to procure the fish seeds from the empanelled fish seed supplier at the **District Reference Rate (DRR)**.
- (vii) The empanelled fish seed suppliers must be agreed to supply the fish seed as per the approved reference rate for which they will enter into an agreement with the concerned DFDO.
- (viii) DFDO who is the Member Secy of the DLSC will place the **EoIs** received before the DLSC within seven days from the date of closing of EoI and will obtain the approval and recommendation of the DRR from DLSC.DFDO will accordingly inform the District Reference Rate (DRR) to the Mission Director, FMS-CMSGUY immediately after approval of the DLSC.
- (ix) The DRR shall remain valid up to March 31, 2021 or till the consignment is delivered and/or completed. In this regard, no claim will be entertained.

- 5. The proposed supply volume may be increased or decreased as per requirement and no payment will be considered against incomplete supply and found not satisfactory by this office.
- 6. The DLSC reserves the right to accept or to reject any or all the EoIs without assigning any reasons what so ever and he does not bind himself to accept the lowest rate.
- 7. No material will be supplied for any of the above works by this office. All taxes, Royalty, Cess, transportation etc. required in connection with the supply to be borne by the selected firm.
- 8. One empanelled supplier of a district can also supply fish seed in maximum three adjacent districts including the districts where he belongs to.
