REQUEST FOR QUOTATION (RFQ)

Scaled quotation of rates affixing non refundable court fee stamp of Rs. 8.25 (Rupees Eight and paisa twenty five) only are invited by the Directorate of Fisheries, Assam, Guwahati from eligible company/manufacture/authorised distributor/authorised dealer of transportation vehicle/refrigerated vehicle manufacturer for onward procurement by the undersigned under the scheme RIDF-XXVI with 20% beneficiary sharing for the following items. The last date of submission of quotation at the office of the undersigned is 14th December, 2021 up to 2.00 PM. The quotations will be opened on the same day at 2.30 pm where the bidders or their authorized representative may be present. If the date of opening of quotation happens to be a holiday or if it is not possible to open quotation on the stipulated date due to any unforeseen reason, then the next working day will be considered as the date for opening of quotation. The quoted rates should be valid for 6 (six) months from the date of submission of quotations. There shall be approximately 70 (Seventy) units of vehicle to be procured by the undersigned.

I	Quotation of Rate for supply of 4wheeler Refrigerated Fish Transport Vehicle (self-contained refrigeration system) in 26 districts of Assam including vehicle registration in the beneficiaries' name, 1st year comprehensive insurance cover complete and embossing of logo etc. over the body as per direction of the department etc. as fish transport commercial vehicle.

Terms & conditions:-

- 1) The bidder must produce copy of valid Manufacturer Certificate/Authorised Distributorship/Authorised Dealership from the Vehicle Company and refrigerated container manufacturer.
- 2) The bidder must produce court fee stamp, copy of PAN and GST registration with his quotation.
- 3) No quotation will be accepted after the stipulated date and time as mentioned.
- 4) The undersigned reserves the right to accept any or to reject all the quotation without assigning any reasons whatsoever and he does not bind himself to accept the lowest rate.
- 5) The required applicable temperature is +5^o C to -25^o C for the 4wheeler Refrigerated Fish Transport Vehicle. The bidder has to submit the detail Brochure/Leaflet, List of Authorized Service Centers and Technical Specification for each specific make & model both for vehicle and refrigerated body. The bidder has to submit the detail Technical Specification about type of materials used in all parts, applicable temperature, cooling capacity of self-refrigeration, capacity of evaporating fan, details of compressor, power consumption & approximate life of compressor, details of condensation, type of defrosting, type & thickness & density & thermal conductivity of puffing material in all six sides of the container, details of doors, details of fixing & fitting of refer unit with the vehicle, make of the refrigeration unit to be fitted as per OEM requirements etc. for each specific make & model
- 6) The proposed vehicle should run on Diesel with BS-VI compliance
- 7) The Min. Warranty in terms of Years & Kilometers or each specific make & model both for vehicle and refrigerated body are to be quoted.
- 8) A bidder may quote rate for any/all model of brand new 4wheeler Refrigerated Fish Transport Vehicle available in vehicle manufacturing company. The bidder may quote rate separately for vehicle cost and refrigeration cost for each make/model inclusive of all taxes etc. However, the evaluation shall be done on the total value of the integrated vehicle. The rate for each integrated vehicle (i.e., 4wheeler Refrigerated Fish Transport Vehicle with self-contained refrigeration system) including all cost should be less than Rs. 15.00 lacs
- 9) The bidder's quoted rates of vehicle for specific make & model must include all the taxes, GST, cess, registration fees, 1st year comprehensive insurance with all necessary fees & tax in the beneficiaries' name and cost of embossing of logo etc. over the body as per direction of the department etc. The bidder should indicate the name of districts where they shall be able to supply the same at their quoted rate. The bidder may also quote different rates for the same make/model for different districts of Assam they shall be able to supply.
- 10) The selected bidders shall be required to deposit the Performance Security Deposit, sign an Agreement with the undersigned and to submit any other additional documents if asked for before issuance of supply order. Supply order shall be issued to the selected bidder on the receipt of the beneficiary share.
