SECTION - II INSTRUCTION TO QUOTATIONERS (ITQ)

Scope of Quotation

- 1.1 The Director of Fisheries, Assam, Guwahati-16 invites quotations from reputed service providers, Firms, Contractors etc. having valid ISP License issued from DOT (Deptt. of Telecommunication) for the work/supply as detailed in the table given in RFQ. The quotationers are requested to read the RFQ document carefully and ensure compliance with all specifications / instructions herein. Non-compliance with specifications / instructions in this document may disqualify the quotationers from the procurement exercise. The Director of Fisheries, Assam reserves the right to select or to reject any quotation wholly or partly without assigning any reason thereof. Incomplete quotations, amendments and additions to quotation after opening or late quotations are liable to be ignored and rejected
- 1.2 Throughout this RFQ document, the terms 'tender', 'quotation' and 'bid' and their derivatives (tenderer / quotationer / quotationer / supplier, tender/ quotation /bid /supply etc.) are synonymous.
- Installation Requirements: -The installation of the connectivity shall be carried out in the office of the Director of Fisheries, Assam, Guwahati, Meen Bhawan. Any statutory requirement for installation and working of all equipment of the ordered Fiber/RF connectivity shall be responsibility of the quotationer. Permission from various authorities may be the sole responsibility of the quotationer.
- Uptime Guarantee: Vendor shall have to guarantee continuous uninterrupted internet line availability along with all the equipment supplied by them and should achieve minimum 95% uptime across 24x7 calculated on monthly basis.
- 1.5 Maintenance & Spares: Vendor shall maintain the entire installation for three years with provision of sufficient Spares with required uptime guarantee.
- 1.6 Training: Vendor shall provide basic training, free of charge for selected staff whenever required to do so by of Directorate of Fisheries, Assam.
 - 1.7 The vendor shall furnish the details of their local centers to support and shall deploy only trained service personnel to resolve the issues which may arise. Maximum time to repair (resolve & recover) a reported break down should be 1 hours. Time for this purpose shall be measured as interval between the time of reporting the problem and the time when the problem is fully solved making the faulty components/functions fully operational.
 - 1.8 If there is a need to shift the ISP modem/router or end point to any other location/room from the current location within the Meen Bhawan campus, the vendor needs to configure entire setup at free of cost during the period.

2. Source of Fund:

The Director of Fisheries, Assam, Guwahati is going to procure the work/supply from Establishment Expenditure Head.

3. One Quotation per quotationer

3.1 Each quotationer shall submit only one quotation for the work. A quotationer who submits or participates in more than one Quotation in the work (other than as a subcontractor or in cases of alternatives that have been permitted or requested) will cause all the proposals with the quotationer participation to be disqualified.

4. Cost of submission of Quotation

4.1 The quotationer shall bear all costs associated with the preparation and submission of this Quotation, and The Director of Fisheries, Assam, Guwahati will in no case is responsible and liable for those costs. No Quotationer shall be entitled to claim any expenses /charges incurred by him or incidental therein in connection with submission of Quotation. The quotationers has to submit the cost of quotation document as detailed in cl.19.6

Clarification of RFQ Documents

Correction of Errors 18.

The quotations determined to be substantially responsive will be checked by The 18.1 Tender Committee for any arithmetic errors. Errors will be corrected as follows:

19.9. The Quotationers are subjected to disqualification, if they have:

19.10 The successful quotationer must have to complete the supply and installation within stipulated time from the date of issue of formal supply order from the undersigned following signing the agreement with the undersigned and deposit of Performance Security Deposits.

19.11 The item after supply, if not found conforming as per specification will be

summarily rejected.

19.12 Rejected items shall be taken back by the quotationer at their own cost within 10 (ten) days of the notice of rejection and should be replenished within next 10 days.

19.13 Warranty:-

- a) One (1) year warranty has to be provided by the firm from the date of the satisfactory installation / commissioning of equipment against the defect of any manufacturing, workmanship and poor quality of components. In case, there is any variation in the warranty as per the specification of the item equipment, the warranty as specified in the specifications shall be final.
- b) The supplier shall provide free maintenance services during the period of warranty. The maximum defect restoration time should not be more than 10 (ten) days. In case the defect/ malfunction of an item cannot be rectified within 10 (ten) days the supplier will be required to arrange for immediate replacement of the same till it is repaired & delivered at their own cost.

ELIGIBILITY CRITERIA: 21.

a) This Invitation for Quotations is open to quotationers who are a service provider, Registered Supplier, Firm, Contractor, partnership firm or a limited Company under Indian Laws having experience as mentioned in RFQ.

b) The quotationer should have valid ISP License issued from DOT (Deptt. of

c) The Quotationer should submit all necessary documents as specified in the RFO.

d) The quotationer should have executed similar project for bandwidth provisioning in govt.

e) The quotationer should not have been blacklisted in any Government/Government undertaking/Public sector companies. A self-declaration undertaking by the quotationer should be submitted along the quotation.

22. RIGHT TO ACCEPTANCE / REJECTION OF QUOTATION:

22.1 The right of acceptance of Quotation rests with the Tender Committee who does not bind itself to accept the leavest any or all the itself to accept the lowest Quotation rests with the Tender Committee any or all the Ouotation(s) received with Quotation(s) received without assigning any reason whatsoever. 22.3 No price escalation will be granted.

23 PERFORMANCE SECURITY: -

a) Within 15 (fifteen) days of receipt of the notification of award by the supplier, as a security for due performance of the contract, the supplier shall furnish performance security to the purchaser for an amount equivalent to 5% of the total contract value in the form of a Bank Guarantee/TDR/FDR from any Nationalized/Regional/Scheduled bank payable at Guwahati in favour of "Director of Fisheries, Assam, Guwahati-16" with a validity for 12 months from the date of commissioning of the supplied item. If the successful quotationer, upon receipt of notification of award, fails to furnish the performance Bank Guarantee within the stipulated time, the notification of award issued shall be automatically got withdrawn and cancelled. During course of time the Performance Security Deposit may have to be revalidated in case of late commissioning of equipment and bank charge/cost if any should be borne by the supplier.

24. AWARD OF CONTRACT:

a) After fulfillment of criteria in the evaluation process and approval from competent authority the notification of award i.e., L.O.A. (Letter of Acceptance) will be issued in favour of selected supplier for supply at approved rates. However, lowest evaluated price shall not be the sole criteria for award of contract.

Within 15 (fifteen) days of receipt of the notification of award i.e., L.O.A, on signing the b) agreement and submission of Performance Security Deposit@ 5% quotationer, the Director of Fisheries, Assam will award the contract to the selected quotationer.

25 DELIVERY & INSTALLATION:

25.1 Goods/Machineries ordered shall be delivered and installed at site indicated in the purchase order within stipulated time from the date of issue of the purchase order for each project/phase wise. All the aspects of safe delivery shall be the exclusive responsibility of the supplier.

25.2 Extension of Delivery Period: If the supplier would unable to complete the project / order within the stipulated time, for which the supplier is responsible, it is required to request for the extension of the delivery period, it may be extended with justified reasons. In case the supplier would fail to complete the order within the stipulated time, Buyer reserves the right to cancel the contract / order and performance security may be forfeited.

26 PENALTY FOR DELAYED SERVICES / LD:

As time is the essence of the contract, Delivery period mentioned in the Purchase Order should be strictly adhered to. Otherwise, the Director of Fisheries, Assam, Guwahati will forfeit PSD/SD and also LD (Liquidated Damage) clause may be applicable /enforced.

If the supplier fails to Supply and install the equipment as per specifications mentioned in the order within the due date, the Supplier may be liable to pay liquidated damages of 1% of order value per every week of delay subject to a maximum of 10% beyond the due date. Such money will be deducted from any amount due or which may become due to the supplier.

The Director of Fisheries, Assam, Guwahati reserves the right to cancel the order in case the delay is more than 4 weeks. Penalties, if any, will be deducted from the Security Deposit.

27 SATISFACTORY INSTALLATION/ FUNCTIONAL DEMONSTRATION: Satisfactory installation / Functional Demonstration and handing over of the equipment mean the faultless functioning of the equipment.

28 TRAINING OF PERSONNEL:

The supplier shall provide the technical training to the personnel involved in the use of the equipment at the site of installation, immediately after completing the installation of the equipment at the company cost if asked by the authority.

29 MERGER / ACQUISITION OF FOREIGN PRINCIPAL:

In case of merger of Foreign Principal with another Firm or acquisition of Foreign Principal by another firm, it shall be obligatory for the New Entity so formed after the merger of the Acquiring Firm, as the case may be, to take over all the duties and obligations / liabilities of the Foreign Principal and the New Entity / Acquiring Firm would ipso facto become liable for all acts of commission or omission on the part of original Foreign Principal as well as Indian Agent.

30 CHANGES OF INDIAN AGENT:

In case the Foreign Principal changes in Indian Agent then it shall be obligatory for Foreign Principal to automatically transfers all the duties and obligations to the New Indian Agent, failing which the Foreign Principal would *ipso facto* become liable for all acts of commission or omission on the part of New Indian Agent.

31 SERVICE MANUAL/CIRCUIT DIAGRAM

It is specifically required that the quotationers will supply all the operating & service manuals and circuit diagrams along with the equipment /machineries.

32 INSURANCES:

The equipment to be supplied will be insured by the vendor against all risks of loss or damage from the date of shipment till such time it is installed at site.

33 SERVICE FACILITY:

At the time of installation, the supplier should inform about the service set up in Guwahati and how capable they are to provide after sales services. The quotationer has to provide service regularly and as and when sought for during the warranty period of one year.


34 SERVICE UPTIME:

The quotationer shall ensure an uptime of 95% for the entire duration. ISP will ensure maintaining services from the nearest service center which should be well equipped with service engineers and sufficient spares. The vendor will do preventive maintenance once a month for upkeep of the system.

35 PENALTIES FOR DOWNTIME:

(a) If the services remain down for any reason for more than 2hours including Saturday and Sunday, then 0.5% of the proportionate contract value may be deducted as penalty and if services remain down from 24hours to one week including Saturdays, Sundays and holidays then 1% of the proportionate contract value may be deducted as penalty.

(b) However, if the services remain down for more than a week then 1.5% of the proportionate contract value may be deducted as penalty for each such weeks up to two weeks after which the security deposit may be invoked and the authority will have right to cancel the order and go for any other ISP.



a) There is no provision of mobilization/ any other advance to the ar ioner. b) The Quotationer should produce delivery challan in triplicate at in triplicate for making payment.

c) Payment will be made to the successful quotationer on receipt of the item in good condition at the destination and the body of challan by at the destination point duly certified signed with stock entry on the body of challan by authorized representative and subject to receipt of necessary fund.

ARBITRATION AND LAWS: 37

In case of any dispute or difference arising out of or in connection with the quotation conditions / order and the Supplier conditions / order and Contract, the Director of Fisheries, Assam, Guwahati and the Supplier will address the discontract, the Director of Fisheries, Assam, Guwahati and the matter shall will address the dispute / difference for a mutual resolution and failing which, the matter shall be referred for additional failing which which is a fisheries be referred for arbitration to a sole Arbitrator to be appointed by the Director of Fisheries, Assam, Guwahati. The Arbitration shall be held in accordance with the provisions of the Arbitration and Conciliation Act, 1996 and the venue of arbitration shall be at Guwahati only. The resolution of the Arbitrator shall be final and binding on both the parties.

38 JURISDICTION:

The courts at Guwahati alone will have the jurisdiction to try any matter, dispute or reference between parties arising out of this quotation / contract. It is specifically agreed that no court outside and other than Guwahati court shall have jurisdiction in the matter.

CORRUPT OR FRAUDULENT PRACTICES 39

The Director of Fisheries, Assam, Guwahati will reject a proposal for award if it determine that the Quotationer recommended for award has engaged in corrupt or fraudulent in competing for the contract in question and will declare the firm ineligible, either indefinitely or for a stated period of time, to be awarded a contract with other department and any other agencies, if it at any time determines that the firm has engaged in corrupt or fraudulent practices in competing for the contractor, or in execution.

WHERE THE QUOTATIONER/SUPPLIER WILL QUOTE HIS RATE? 40.

The Quotationer/Quotationer/Supplier has to quote the rate/value in the "Form of Quotation" against the work/supply.

PROCESS TO BE CONFIDENTIAL

Information relating to the examination, clarification, evaluation and comparison of Quotations and recommendations for the award of a contract shall not be disclosed to Quotationers or any other person officially concerned with such process until the award to the successful Quotationer has been announced. Any effort by a Quotationer to influence the Director of Fisheries, Assam in processing of Quotations or award decision may result in the rejection of his Quotation.
